I am sure many of you, like me, are watching with interest the plans unfolding from the coalition government. The publication of the White Paper: 'Equity and excellence: Liberating the NHS' sets out proposals to make the NHS a world-class service that is easy to access, treats people as individuals and offers care that is safe and of the highest quality.

The Secretary of State for Health, Andrew Lansley, has outlined the three key areas of focus for the coalition government as follows: • Patients will be at the heart of everything that the NHS does – no decisions about me without me. • Healthcare outcomes in England Welcome by John Savage CBE Chairman

that are among the best in the world – including for the most vulnerable.

• Empowering clinicians to deliver results, setting clinicians free from micromanagement and top-down control, shifting the focus firmly towards the needs of patients and improved health outcomes.

There will be considerable challenges ahead, particularly in relation to the existing Strategic Health Authorities and Primary Care Trusts, which are to be abolished by 2013. There will be uncertainty about what jobs and organisations will exist in the new landscape and what this means for staff at all levels. However, there is a strong commitment



in the White Paper to the Foundation Trust model. We will therefore be working with partner organisations, GP commissioners, staff, patients and with you, to ensure not only that UH Bristol is fit for the future, whatever it holds, but is ready to play an active part in shaping the changes locally.

We are very serious about ensuring you are able to play as active a role as you would like in the discussions and consultations about the future of the NHS. We have produced a survey in this newsletter, asking you how you'd like us to communicate with you and, importantly, how we can ensure we are listening to you. Please take the time to complete it.

I am hugely passionate about this Trust and the wider NHS and I look forward to working together with you to ensure its future.

The Trust launches its new values

The Trust's new values were launched at the end of June, after staff, patient and member workshops.

The four values – Respecting everyone, Embracing change, Recognising success and Working together – are rooted in the experience of staff.

Each of the four values is based on behaviour we expect from our staff.

For example, 'working together' means working together to achieve what is best for patients, supporting each other across the whole Trust, listening to everyone and working



in partnership inside and outside our organisation.

These values reflect the Trust's ongoing aim to provide a service that's high quality, cost effective and safe for our patients.

The values were launched with a series of ward walkrounds and a poster

campaign (one of the posters is pictured, above left) across all our hospital sites, which was kindly funded by our charities Above & Beyond, The Grand Appeal and the Bristol Royal Infirmary League of Friends.
