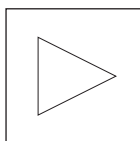

What skills do you feel you bring to the role?

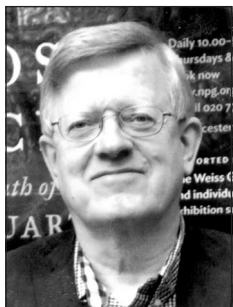

Any other information that you feel is relevant?

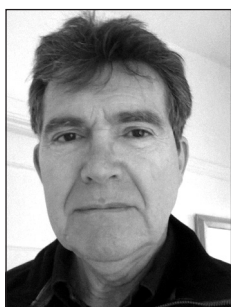

Any other information that you feel is relevant?

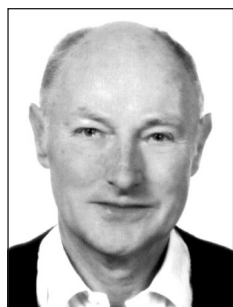

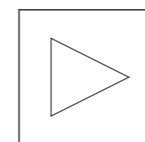

I can use all methods for Communications e-mail Facebook Skype Instant Messenger.

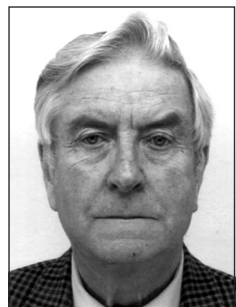

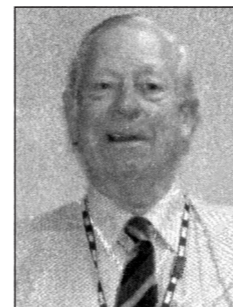

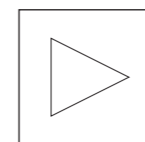

Any other information that you feel is relevant?

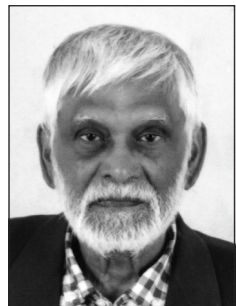

I was a member of the Commission for Patient and Public Involvement in Health for 2 years, with responsibility to help in shaping better health for the public.

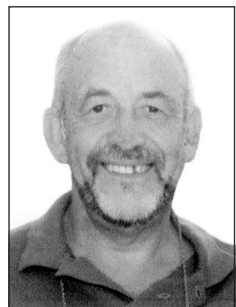
I am a member of support groups for patients including Prostate Cancer, Heart Diseases and Motor Neurone Disease.

18 months I have been helping in the BRI in various voluntary roles.

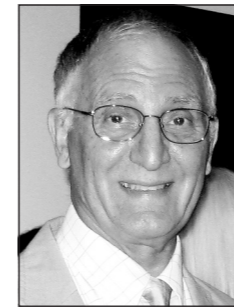
