Thank you for your request for information under the Freedom of Information Act 2000. The Trusts response is as follows:

It would be much appreciable if you could provide me the Medicine usage Information according to Freedom of Information act for the below Mentioned Anti Biotics during the Past 5 years.2011/12,2012/13, 2013/14, 2014/15, 2015/16. It would be much appreciable if you provide the Pack size information of the usage if possible:

- Cefuroxime powder for injection or infusion 250/750/1500 mg vials.
- Ceftriaxone powder for injection or infusion 1 gram and 2 gram vials.
- Ceftazidime powder for injection or infusion 500/1000/2000 gram vials.
- Cefotaxime powder for injection or infusion
- Meropenem powder for injection or infusion 500/1000 gram vials.
- Imipenem Cilastatin powder for injection or infusion 250/250 mg and 500/500 mg vials
- Piperacillin Tazobactam powder for injection and infusion 4gram/500mg vials.

Please see table below. Please note we have not provided data for 2011/12 as we do not hold this information.
