Under Section 40(2) of the Freedom of Information Act, relating to a breach of Principle 1 of the Data Protection Act we are required to judge as to whether the disclosure of the information of less senior staff would be fair and reasonable to our employees. Please note the figures in the table below reflects a total of aerobic and anaerobic bottles (a pair is standard for adult patients) and paediatric bottles (a single bottle for

smaller volume from children). Children with central lines will often have an adult set taken.
