Thank you for your request for information under the Freedom of Information Act 2000. The Trusts response is as follows:

#### 1. Baby deaths

a. How many term stillbirths and perinatal deaths have there been at your trust in each year the past decade (from 2006-2016)?

Stillbirths:

#### **Perinatal Deaths:**

We are unable to provide figures for perinatal deaths as requested as we do not have a specific category for this on the Trust's incident reporting system. A perinatal death is a death that occurs within 7 days of birth. A neonatal death includes any death that occurs within the neonate age rage (under 28 days of age), thus all perinatal deaths are neonatal deaths. The table below shows the total number of 'neonatal deaths' per year but please be aware that because not all neonatal deaths are only perinatal deaths we cannot be sure that the figures provide the specific information you require and the figures below are likely to be higher than the ones you requested.
