Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- How many "clean rooms" exist within your ophthalmology units?
 Theatres and 5 rooms cleaned to theatre standards are used across BEH OPD and outreach centres.
- 2. What proportion of ophthalmology 1st and follow-up outpatient appointments were associated with a diagnosis of
 - a. primary open angle glaucoma
 - b. age-related macular degeneration
 - c. diabetic macular oedema in the years 2016/17 & 2017/18?

University Hospitals Bristol NHS Foundation Trust does not collect diagnosis in its outpatients system. This information might be present in the patient notes which is free text and therefore not retrievable via our information systems.

 How many SLT (selective laser trabeculoplasty) machines do you have in your ophthalmology units One SLT machine.

and how many procedures were performed in 2016/17 & 2017/18?

and what was the split between theatre & clinic? The split would be 95% clinic and 5% theatre.
