 The Trust's pay rates for WLI sessions are £75 £100 per hour.
- 2. If it would be possible to have a total annual expenditure for the financial year of 2019 so far, as well as the hourly or session salary for each WLI session, and any fluctuations that have occurred in this rate over this financial year thus far.
